## CLEAR CREEK CONDOMINIUM ASSOCIATION STATEMENT OF ELECTION TO BE TREATED AS A COMMON INTEREST COMMUNITY UNDER THE COLORADO COMMON INTEREST OWNERSHIP ACT

The undersigned, on behalf of the Clear Creek Condominium Association ("Association"), pursuant to C.R.S. § 38-33.3-118, hereby gives notice of the election of the Clear Creek Condominium Association to be treated as a Common Interest Community under C.R.S. § 38-33.3-101, *et seq.* ("Act") and amendments thereto.

1. The name of the Common Interest Community is Clear Creek Condominiums, and the association is the Clear Creek Condominium Association.

2. The Association has elected to accept the provisions of the Act under C.R.S. § 38-33.3-118.

Pursuant to C.R.S. § 38-33.3-118, on July 18, 2015, the Board of Directors 3. of the Association adopted a resolution to submit for a vote of the members at the Annual Meeting of the Association on August 1, 2015, the question of whether the Association would elect to be treated under the provisions of the Colorado Common Interest Ownership Act, C.R.S. § 38-33.3-101, et seq. A written notice of the 2015 annual meeting stating that the question of whether the Association should elected to be treated as a Common Interest Community under the Act was placed on the agenda for the 2015 Annual Meeting and sent to all members of the Clear Creek Condominium Association. A notice that the members of the Association had adopted a resolution to elect to be treated as a Common Interest Community under the Act was also sent to all first mortgagees of record by certified mail and a notice directed to all first mortgagees was published in a newspaper for two consecutive weeks. A quorum was present at the meeting. At least sixty-seven percent (67%) of the owners of all units and of the first mortgagees approved the election to be treated as a Common Interest Community under the Act.
